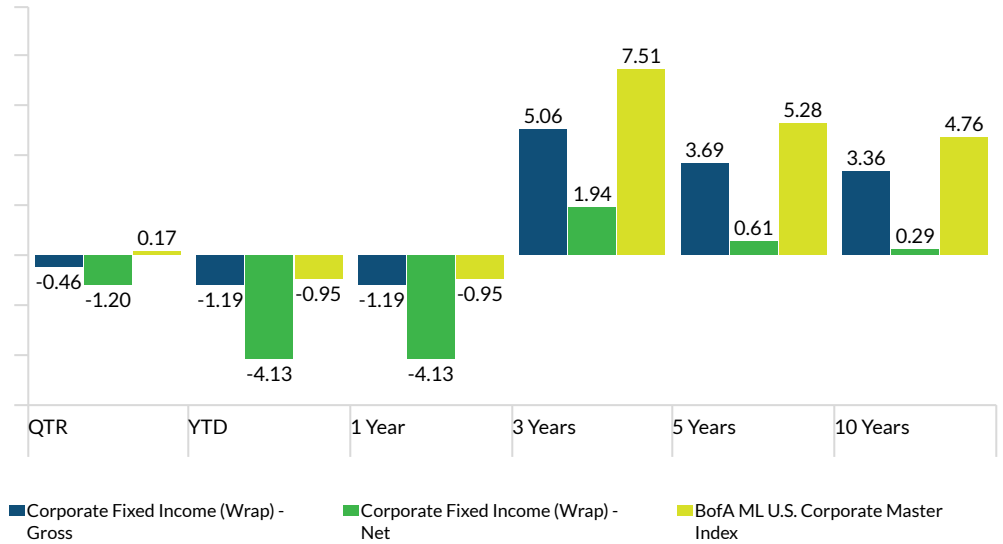

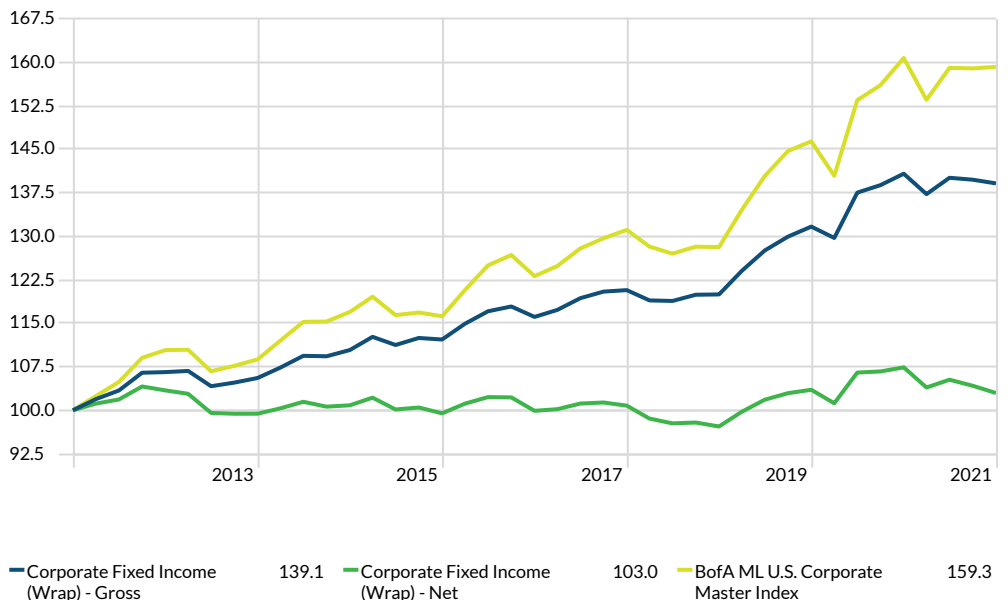

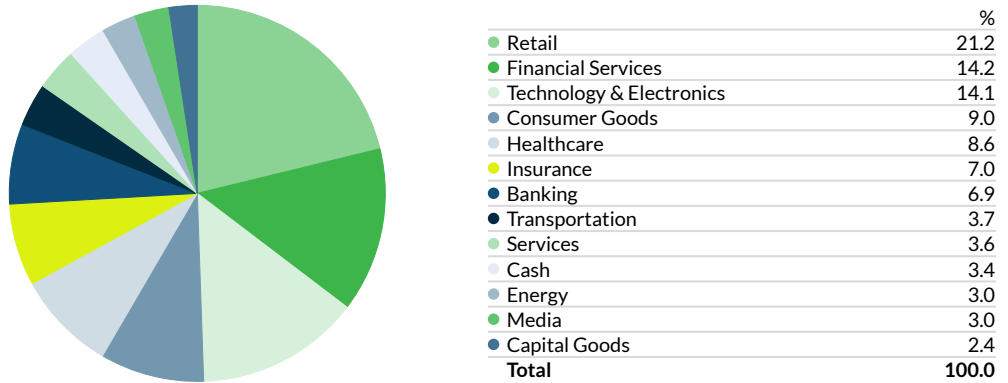

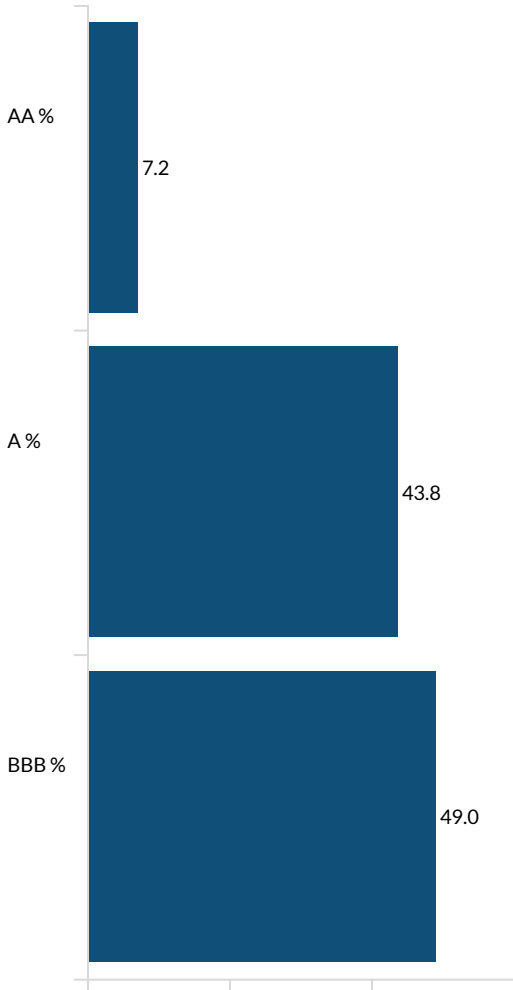

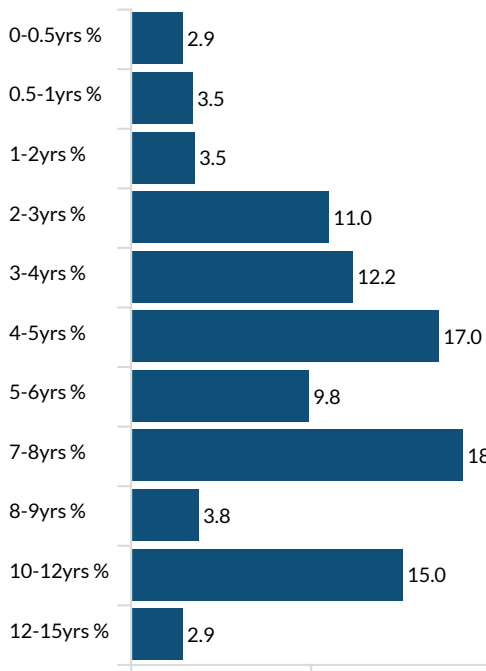
Model Portfolio Corporate Sector Breakdown*



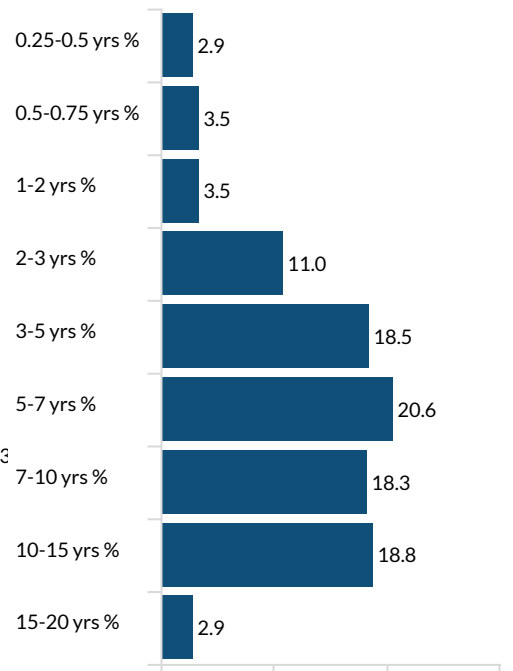
Model Portfolio Credit Rating Breakdown*

The Bank of America Merrill Lynch Corporate Master tracks the performance of U.S. dollar denominated investment grade corporate debt publicly issued in the U.S. domestic market.

The U.S. Dollar is the currency used to express performance. The performance reflects the reinvestment of dividends and other earnings to the extent that client accounts included in the composite elected to reinvest dividends and earnings.
